24 follows:

GENERAL ALLEGATIONS

(Common to All Causes of Action)

25 1. Plaintiff Charles Arnold is an individual, residing and doing business in Los

1 2. Defendant Akin Gump Strauss Hauer & Feld LLP ("Akin") is a limited liability
2 partnership, with an office and doing business in Los Angeles, California. Defendant Akin is a
3 law firm, practicing law in the State of California.

4 3. Defendant Douglas A. Rappaport ("Rappaport") is an individual. Rappaport is not
5 licensed to practice law in the State of California, but did business and purported to act as an
6 attorney in Los Angeles, California.

7 4. Defendant Rappaport is a partner of defendant Akin, and acted in such capacity.

8 5. The true names and capacities, whether individual, corporate, partnership, associate
9 or otherwise, of the defendants named herein as DOE 1 through DOE 100, inclusive, are unknown
10 to plaintiff who therefore sues said defendants by such fictitious names. Plaintiff will seek leave
11 to amend this complaint to show their true names and capacities when the same have been
12 ascertained. Plaintiff is informed and believes and thereon alleges that each of the defendants
13 designated herein as a DOE is responsible in some manner for the happenings and events
14 hereinafter alleged and intentionally or otherwise caused the losses and damages as herein alleged.
15 Plaintiff is informed and believes and on such information and belief alleges that at all times
16 herein mentioned, defendants, and each of them, were the agents, servants, partners, associates,
17 representatives and employees of the other defendants, and each of them, and in doing the things
18 herein alleged, were acting within the course and scope of such agency, partnership and
19 employment.

20 **FIRST CAUSE OF ACTION**

21 **(Libel Per Se)**

22 **(By Plaintiff Against All Defendants)**

23 6. Plaintiff incorporates by reference the foregoing paragraphs of this complaint as if
24 the same were fully set forth herein.

25 7. On or about January 26, 2011, defendants sent a letter to James Worsham
26 ("Worsham") and others. Defendants knew that Worsham was under strong pressure to
27 communicate defendants' statements to additional people, and he did so.

1 8. The people who saw the letter reasonably understood that statements in the letter
2 were about Mr. Arnold, because the letter said that it referred to Mr. Arnold.

3 9. These people reasonably understood the statements to mean that Mr. Arnold had
4 lied, that he had committed a crime, and that he had violated his fiduciary duties.

5 10. The statements tend directly to injure Mr. Arnold in respect to his office,
6 profession, trade and business as a business consultant and advisor, by imputing to him general
7 disqualification in those respects which the office and occupation peculiarly requires, and by
8 imputing things with reference to his office, profession, trade, and business that have a natural
9 tendency to lessen its profits. The statements, by natural consequence, cause actual damage.

10 11. The statements were false.

11 12. Defendants knew that the statements were false when made.

12 13. Defendants made the statements with malice and ill will. Defendants' purpose in
13 writing the letter was to disrupt Mr. Arnold's business and relationships, and to blackmail Mr.
14 Arnold into acceding to the illegal demands of defendants' secret clients.

15 14. The law presumes that Mr. Arnold has suffered harm to his reputation, as well as
16 shame, mortification and hurt feelings, as a result of defendants' libel per se. Without presenting
17 evidence of damage, Mr. Arnold is entitled to receive compensation for his assumed harm in
18 whatever sum the jury believes to be reasonable.

19 15. Defendants' wrongful conduct was also a substantial factor in causing the
20 following actual damages:

21 a. Harm to Mr. Arnold's property, business, trade, profession, and occupation;
22 and

23 b. Expenses that Mr. Arnold had to pay as a result of the defamatory
24 statements, including, but not limited to, legal fees.

25 16. Defendants acted with malice, oppression and fraud, justifying an award of
26 damages to punish defendants.

PRAYER FOR RELIEF

WHEREFORE, Plaintiff prays for judgment as follows:

1. For presumed damages in excess of \$10 million, in an amount to be determined by the jury according to proof at trial;
2. For actual damages in excess of \$10 million, in an amount to be determined by the jury according to proof at trial;
3. For punitive and exemplary damages in excess of \$100 million, in an amount to be determined by the jury according to proof at trial;
4. For attorneys' fees, costs and expenses;
5. For costs of suit; and
6. For such other and further relief as the Court deems just and proper.


